Nationwide Crime Analysis April 2022 vs 2021

Preliminary figures for April 2022 indicate that major crimes increased by 20% with 377 cases, compared to 314 over the same period in 2021. There was a 27% regional decrease in crime on the Family Islands when compared to April 2021. There were regional increases in New Providence and Grand Bahama at rates of 26% and 30% respectively, compared to the same period in 2021.

For the period in review, crimes against the property increased by 3%, with 263 incidents, compared to 255 for the same period in 2021. There was a regional decreased of 23% in property crimes on the Family Islands over the same period in 2021. However, there were regional increases of at rates of 8% in New Providence and 10% in Grand Bahama. Crimes against the person increased by 93%, with 114 incidents, compared to 59 for the same period in 2021. There was a 67% regional decrease in crimes against the person on the Family Islands when compared to April 2021. However, there were regional increases at rates of 89% in New Providence and 350% in Grand Bahama.

Homicides increased by 30% with 13 incidents, compared to 10 for the same period in 2021. New Providence accounted for 92% of murders for the period under review. Victims between the ages of 18 and 35 represented 38% of all homicides. Based on preliminary figures, homicides were more likely to occur on a Thursday than any other day of the week. The overall solvency rate for murder for the period in review stands at 38%. Homicides were more prevalent in the **Southeastern Division**, accounting for 42% of overall incidents. Fatal gunshot wounds were the leading cause of death for homicides accounting for 13 incidents.

Armed robberies increased by 205% with 61 incidents, compared to 20 over the same period in 2021. Armed robberies occurred mostly between the hours of 4pm and 12am. Based on preliminary figures armed robberies were more likely to occur on a Friday than any other day of the week. Armed robberies were more prevalent in the **Southwestern and Southeastern Divisions**, accounting for 36% of incidents. Most armed robberies occurred at residences and at the street level. Firearms continue to be the weapon of choice for the commission of armed robberies. For the period in review, males represented the highest percentage of victims at 74%, compared to female victims at 26%.

Robberies increased by 100% with 14 incidents reported, compared to 7 for the same period in 2021. Robberies occurred mostly between the hours of 6pm and 12 am. Based on preliminary figures, robberies were more likely to occur on a Sunday than any other day of the week. Females represented the highest percentage of victims at 64%, compared to male victims at 36%.

Stolen vehicles decreased by 13% with 20 incidents, compared to 23 in April 2021. **Nissans** were the most targeted vehicles of choice, representing 25% of all vehicles stolen. The **Nissan Bluebird** was the most predominant model stolen. While residences were the most targeted locations; stolen vehicle cases were more prevalent in the **Southwestern Division** which accounted for 37% of the overall total. Thirty-five percent of stolen vehicles were recovered for the month of April 2022.

Stealing from vehicles decreased by 24% with 38 incidents, compared to 50 for the same period in 2021. The most frequent items stolen included electronics, tools and documents. **Nissan Cubes** and **Notes** were mostly targeted. Based on preliminary figures, stealing from vehicles were more likely to occur on a Thursday than any other day of the week. Stealing from Vehicle cases were mostly reported in the **Northeastern Division** for the month of April 2022, accounting for 30% of reported cases.

Housebreakings increased by 21% with 58 incidents, compared to 48 for the same period in 2021. The New Providence District accounted for 45 or 78% of all housebreakings, most of which occurred in the Eastern, Cable Beach and Southwestern Divisions accounting for 41% of all cases. Grand Bahama, including Abaco and Bimini, accounted for 6 or 10% of housebreakings including 1 in Southwestern, 1 in Northeastern and 1 in Southwestern. The Family Islands District accounted for the remaining 7 or 12%, most of which occurred in Eleuthera with 3 incidents reported. Based on preliminary figures, housebreakings were more likely to occur on a Thursday than any other day of the week.

Shopbreakings decreased by 7% with 38 incidents, compared to 41 for the same period in 2021. The **New Providence District** accounted for 25 or 66% of shopbreakings, most of which occurred in the **Northeastern Division** with 16 % of all cases. **Grand Bahama**, including **Abaco and Bimini**, accounted for 10 or 26% of shopbreakings, most of which occurred in **Central** and **Eight Mile Rock** with 3 incidents each. The **Family Islands District** accounted for the remaining 3 or 11%, most of which occurred in **Andros**. Based on preliminary figures, shopbreakings were more likely to occur on a Monday than any other day of the week.

For the period in review, a total of 43 **firearms** and 295 rounds of ammunition were discovered and seized throughout the Commonwealth of The Bahamas. As a result, 29 persons were charged with possession of illegal firearms. Additionally, **ShotSpotter** detected 55 gunshot incidents, consisting of 35 multiple shots, 16 single shot incidents and 4 probable shots, totaling 185 rounds discharged.

Officers of the Royal Bahamas Police Force conducted 2,220 field check patrols, 101 road checks and executed 43 search warrants throughout the Commonwealth of The Bahamas. As a result of these efforts, 999 persons were arrested for various major and minor offences. Of this number, 73% or 728 suspects were charged before the Court. There were 163 convictions in the Magistrates Court, 20 acquittals, 79 matters were discharged and 45 matters were withdrawn by the virtual complainant.





For the period in review, murders increased by 30% with 13 cases compared to 10 over the same period in 2021.











Murder Solvency Rate April 2022






For the period in review, armed robberies increased by 205% with 61 incidents, compared to 20 for the same period in 2021.







For the period in review, stealing from a vehicle decreased by 24% with 38 incidents, compared to 50 over the same period in 2021.





Stealing from Vehicle - Location Type April 2022





Detection Rates - All Bahamas April 2022




Cybercrime

Persons Arrested

For the period in review, the police arrested 999 persons for various major and minor offences throughout the Commonwealth of The Bahamas. **New Providence** accounted for 686 or 69% of all persons arrested, **Grand Bahama & the Northern Bahamas** accounted for 251 or 25%, and the **Family Islands District** accounted for 64 or 6%. Males accounted for 845 or 85% of arrests, and females accounted for the remaining 154 or 15% of arrests.







Persons Charged


For the period in review, the police charged 728 persons for various major and minor offences throughout the Commonwealth of The Bahamas. **New Providence** accounted for 620 or 85% of all persons arrested, **Grand Bahama & the Northern Bahamas** accounted for 103 or 14%, and the **Family Islands District** accounted for 5 or 1%. Males accounted for 568 or 78% of persons charged, and females accounted for the remaining 160 or 22% of persons charged.






For the period in review, there were 999 persons arrested, of which 73% or 728 suspects were charged before the Court.









Court Case Disposition







Productivity Loss

For the period in review, the Organization accounted for 3,166 sick days at an estimated loss of \$414K. Police Officers on industrial leave accounted for 528 or 17% of the overall sick days. The contracted ranks accounted for \$335K or 81% of all productivity losses due to sick reports. The New Providence District accounted for \$354K or 85% of the overall productivity losses with Grand Bahama District and the Family Islands District accounting for 12% and 3% respectively.







Productivity Loss- District
