Nationwide Crime Analysis February 2022 vs 2021

Preliminary figures for February 2022 indicate that major crimes increased by 4%, with 331 cases, compared to 319 over the same period in 2021. The Grand Bahama district crime figures remain unchanged with 46 cases. There was a 45% regional decrease in crime on the Family Islands when compared to the same period in 2021. However, there was a regional increase at a rate of 11% in New Providence when compared to the same period in 2021.

Crimes against the property increased by 6%, with 257 incidents, compared to 242 over the same period in 2021. There was a regional decrease on the Family Islands at a rate of 46%, with 15 incidents compared to 28 over the same period in 2021. However, there were regional increases at rates of 11% and 23% in New Providence and Grand Bahama respectively. Crimes against the person decreased by 4%, with 74 incidents, compared to 77 over the same period in 2021. There were regional decreases at rates of 73% in Grand Bahama and 40% on the Family Islands. However, there was an 11% regional increase in New Providence.

Homicides decreased by 67% with 4 incidents, compared to 12 in the same period 2021. New Providence accounted for 100% of murders for the period under review and the overall solvency rate for murder for February 2022 stands at 50%. Victims between the ages of 18 and 35 represented 75% of all homicides. Based on preliminary figures, homicides were more likely to occur on a Thursday than any other day of the week. Homicides were more prevalent in the **Southwestern Division**, accounting for 50% of the overall total incidents. Fatal gunshot wound was the leading cause of death for homicides accounting for 4 incidents.

Armed robberies increased by 75%, with 42 incidents, compared to 24 over the same period in 2021. Armed robberies occurred mostly between the hours of 7pm and 11pm. Based on preliminary figures armed robberies were more likely to occur on a Tuesday than any other day of the week. Armed robberies were more prevalent in the **South Central** and **Southeastern Divisions** for the month of February, accounting for 33% of the overall total. Most armed robberies occurred at business establishments, at the street level and at residences respectively. Firearms continue to be the weapon of choice for the commission of armed robberies. For the period, males represented the highest percentage of victims at 45%, compared to female victims at 55%.

Robberies decreased by 58%, with 5 incidents, compared to 12 over the same period in 2021. Robberies occurred mostly between the hours of 6pm and 8 pm. Based on preliminary figures, robberies were more likely to occur on a Saturday than any other day of the week. Males represented the highest percentage of victims at 80%, compared to female victims at 20%.

Stolen vehicles increased by 12%, with 29 incidents, compared to 26 over the same period in 2021. **Nissans** were the most targeted vehicles of choice, representing 38% of all vehicles stolen. **Nissan Note** and **Nissan Cube** were the most predominant models stolen, while residences were the most targeted locations. Stolen vehicle cases were more prevalent in the **Southwestern Division**, accounting for 25% of the overall total. Thirty-eight percent of stolen vehicles were recovered for the month of February 2022.

Stealing from vehicles decreased by 43%, with 31 incidents, compared to 54 over the same period in 2021. The most frequent items stolen included electronics, tools and documents. **Honda Accords** were

the most targeted vehicles. Based on preliminary figures, stealing from vehicles were more likely to occur on a Sunday and Wednesday than any other day of the week. Stealing from Vehicle cases were mostly reported in the **Southwestern Division** for the month of February accounting for 23% of reported cases.

Housebreakings decreased by 27 %, with 37 incidents, compared to 51 over the same period in 2021. The New Providence District accounted for 26 or 70% of all housebreakings, most of which occurred in the Eastern and Southwestern Division, accounting for 32% of all cases. Grand Bahama, including Abaco and Bimini, accounted for 5 or 14% of housebreakings including 3 in Southwestern, 1 in Eight Mile Rock and 1 in West End. The Family Islands District accounted for the remaining 6 or 16%, most of which occurred in Andros with 3 incidents reported. Based on preliminary figures, housebreakings were more likely to occur on a Tuesday and Friday than any other day of the week.

Shopbreakings increased by 95%, with 41 incidents, compared to 21 over the same period in 2021. The **New Providence District** accounted for 30 or 73% of shopbreakings, most of which occurred in the **Northeastern Division** with 17% of all cases. **Grand Bahama**, including **Abaco and Bimini**, accounted for 10 or 24% of shopbreakings, most of which occurred in the **Southwestern Division** with 6 incidents. The **Family Islands District** accounted for the remaining 1 or 2%, which occurred in **Andros**. Based on preliminary figures, shopbreakings were more likely to occur on a Monday than any other day of the week.

For the period in review, a total of 29 **firearms** and 295 rounds of ammunition were discovered and seized throughout the Commonwealth of The Bahamas. As a result, 29 persons were charged with possession of illegal firearms. Additionally, **ShotSpotter** detected 59 gunshot incidents, consisting of 42 multiple shots, 16 single shot incidents and 1 probable shots, totaling 237 rounds discharged.

The Force responded to 1 Covid 19 call for assistance. Furthermore, officers of the Royal Bahamas Police Force conducted 2,496 field check patrols, 84 road checks and executed 20 search warrants of arrest throughout the Commonwealth of The Bahamas. As a result of these efforts, 1061 persons were arrested for various major and minor offences. Of this number, 47% or 494 suspects were charged before the Court. There were 143 convictions in the Magistrates Court, 1 death, 8 acquittals, 71 matters were discharged and 26 matters were withdrawn by the virtual complainant.

For the month of February 2022, reports of murder decreased by 67% with 4 cases compared to 12 over the same period in 2021.











Murder Solvency Rate February 2022


For the month of February 2022, armed robberies increased by 75% with 42 incidents, compared to 24 over the same period in 2021.




















Housebreakings



Stealing from Vehicle


For the month of February 2022, reports of stealing from a vehicle decreased by 43%, with 31 incidents, compared to 54 over the same period in 2021. Items of choice stolen from vehicles mostly consisted of electronics, documents and cash. Residences were the most targeted areas for this crime, representing 35% of stealing from vehicles incidents.








Stealing from Vehicle - Items Stolen February 2022



Detection Rates - All Bahamas February 2022




Crimes Against the Person - Detected Crimes February 2022




Cybercrime

Persons Arrested

For period in review, the police arrested 1,061 persons for various major and minor offences throughout the Commonwealth of The Bahamas. **New Providence** accounted for 704 or 66% of all persons arrested, **Grand Bahama & the Northern Bahamas** accounted for 263 or 25%, and the **Family Islands District** accounted for 94 or 9%. Males accounted for 908 or 86% of arrests, and females accounted for the remaining 153 or 14% of arrests.









Persons Charged


For the period in review, the police charged 494 persons for various major and minor offences throughout the Commonwealth of The Bahamas. New Providence accounted for 322 or 65% of all persons charged, Grand Bahama and the Northern Bahamas accounted for 105 or 21%, and the Family Islands District accounted for 67 or 14%. Males accounted for 425 or 86% of persons charged, and females accounted for the remaining 69 or 14% of persons charged.




Charged - District

For the period in review, there were 1,061 persons arrested, of which 47% or 494 suspects were charged before the Court.









Court Case Disposition






Productivity Loss


For the period in review, the organization accounted for 3,378 sick days at an estimated loss of \$415K. Police officers on industrial leave accounted for 668 or 20% of the overall sick days. The contracted ranks accounted for \$355K or 86% of all productivity losses due to sick reports. The New Providence District accounted for \$337K or 81% of the overall productivity losses with Grand Bahama District and the Family Islands District accounting for 10% and 9% respectively.




Sick Days by District
